Cloud repatriation involves relocating workloads from the public cloud to on-premises or private cloud environments. By repatriating certain workloads, organisations can regain control of IT environments and align infrastructure to address evolving business needs.

Why companies consider repatriation:

Cost Savings	Public cloud expenses (e.g., storage, compute, egress fees) can become unpredictable and expensive. Utilising on-prem infrastructure allows for fixed, predictable costs.
Performance	On-prem solutions can offer better performance for latency- sensitive applications, with some workloads running more efficiently on specialised hardware that cloud providers may not support.
Compliance	Data sovereignty and regulatory compliance impact most organisations, with some regulations mandating where sensitive data can be stored and strict guidelines on data handling. For example, some organisations need data sovereignty, to be absolutely certain that their data does not leave the UK. This is not always clear in Public Cloud.
Realisation	The three points above create a sum-total that a particular workload or application isn't cloud ready yet. We assist our clients to bring costs, performance and compliance under control while new preparations are made for a move to Public cloud. With no egress or ingress charges on our Private Cloud platform, clients have the time-pressure of changing a critical app removed from the equation which, in turn, leads to better long term architecture decisions.
